SHORT DESCRIPTION

The Model EU Brussels is an **intensive course conducted by the Eastwest European Institute in partnership with Associazione Diplomatici**. University students and recent graduates with the most varied and multicultural backgrounds are invited to **rethink the concept of Europe by proposing and discussing their ideas and solutions to current issues**.

By taking on the role of Council members, and Parliamentarians, **participants will build a network with other young professionals** with a strong awareness of European values.

The main goal of the project is to **make participants learn more about the functioning of the main European institutions** thanks to direct experience of the ordinary EU legislative procedure with the learning by doing method, through a three-day-long simulation in Brussels.

SIMULATION
